Announcements

- Delaware City Day vehicle permits are now being distributed. Delaware City residents that live east of Fifth Street will receive two permits for each household. Residents can pick up passes daily at the Delaware City Police Department from 8:00 a.m. to 5:00 p.m. **The last day permits will be issued will be Thursday evening, July 19, 2018 at 9:00 p.m.**
- Parking restrictions for Delaware City Day will go into effect beginning at 6:00 a.m. Saturday morning July 21, 2018. The following parking restrictions will take effect:
 - Beginning at 6:00 a.m., there will be no parking on Clinton Street from Fifth Street to the circle at Battery Park for the Delaware City Parade. Violators will be towed!
 - At the conclusion of the parade, parking restrictions on Clinton Street from Second Street (WSFS Bank) to the circle at Battery Park will remain in effect. Parking on Clinton Street except in front of Town Hall will be permitted.

- Beginning at 5:00 p.m. Washington Street at Front Street will be closed to vehicular traffic (except emergency vehicles) until one hour after the fireworks have ended.
- Beginning at 6:00 a.m. Williams Street will be closed at Clinton Street until one hour after the fireworks.
- Beginning at 6:00 a.m. Canal Street at Williams Street will be closed until one hour after the fireworks have ended.
- Beginning at 6:00 a.m. Front Street will be closed at Clinton Street until one hour after the fireworks have ended.
- At approximately 5:00 p.m. on Saturday, July 21, 2018, the east side of the city will be closed to the general public. Only residents with a green 2018 Delaware City resident permit will be permitted to enter the city at the intersection of 5th and Clinton Street. Motorists that do not have a resident permit will be directed to Ft. DuPont to park and to catch a shuttle.
- Also at 5:00 there will be no vehicular traffic permitted to enter Delaware City at the intersection of State Route 9 and State Route 72.
 - Traffic coming south from both SR 72 (Wrangle Hill Road) and SR 9 (River Road) will be directed to proceed on Clark's Corner Road towards Cox Neck Road. There they will make the left turn onto Cox Neck Road into Delaware City. This will hopefully alleviate the traffic congestion at the intersection of Fifth and Clinton Streets.
- Shuttle Service for Delaware City Day is as follows:
 - Disabled parking will be at the parking lot adjacent to the Delaware City Fire Company. A shuttle for disabled individuals will begin at 12:00 noon and end one hour after the fireworks have ended.
 - There will be two fourteen passenger vans used as a shuttle for Delaware City Day. They will begin at 4:00 p.m. and run until one hour after the fireworks have ended. The first shuttle will run between Ft. DuPont and the WSFS Bank at Second and Clinton Street. The second shuttle will run from Harbor Estates and the WSFS Bank at Second and Clinton Street.
- We would also like to remind residents that pets are not permitted on Clinton Street between Second Street and Battery Park beginning at 5:00 p.m. on Delaware City Day.
- Pursuant to Chapter 27, Article II, Section 27-6 of the Delaware City Code and in the interest of public safety, Mayor Green on July 9, directed that Harbor Street between Clinton Street and Washington Street become a Fire Lane. As such, it will be posted in the near future as a no parking zone.
